Urgent directions regarding GRAP

Dear Sir

EPCA has just received the recommendation from the CPCB Task Force on the urgent measures to be taken under the Graded Response Action Plan (GRAP).

As you know, the NCR air quality has deteriorated sharply because of the adverse weather condition. The ventilation index – which allows for dispersion is extremely poor and it is expected that these conditions will prevail for the next 2 days. Within a few hours the region would have had severe air quality conditions for the past 48 hours.

In light of this and the expected weather conditions for the coming few days, the CPCB Task Force has recommended the following, which EPCA is directing for urgent compliance:

- Industries located in <u>hotspot industrial areas</u> (Wazirpur, Mundka, Narela, Bawana, Sahibabad, Faridabad) to remain closed until December 26, 2018.
- Construction activities in Delhi, Faridabad, Gurugram, Ghaziabad and Noida to remain closed till December 26, 2018.
- Traffic police to deploy special teams and ensure congestion free traffic flow particularly in identified high traffic corridors.
- Concerned police department to strictly ensure that non-destined heavy duty vehicles travel through eastern and western peripheral expressways.
- Concerned agencies to ensure strict action against illegal industries.
- Agencies must intensify ground actions and make all efforts to control polluting activities, particularly waste burning.

Please ensure compliance with the above directions.
