5	Impact on financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible	<p>There is no material impact on the financial, operation, or other activities of the Company due to the said order.</p> <p>Considering that the Company and the other Opposite Party in the complaint are directed to pay Rs. 10,000/- as cost of tyre to the complainant alongwith interest @ 9% P.A. from the date of filing of the complaint, till realization of the entire amount on account of mental tension, harassment and mental stress and Rs. 2,000/- as cost litigation, the Company will have to pay approx.
